

The Performance grading of the learner shall be on the Ten point grading system as under:

THE TEN (10) POINT GRADING SYSTEM

The performance grading shall be based on the aggregate performance of internal assessment and semester end examination:

STANDARD OF PASSING (for self financed courses)

A Student should secure minimum of 40% marks in INTERNAL ASSESSMENT & IN SEMESTER END EXAMINATION SEPARATELY.

i.e. 10 out of 25 **IN INTERNAL ASSESSMENT**

30 out of 75 **IN SEMESTER END EXAMINATION**

STANDARD OF PASSING (for B.com)

A Student should secure minimum of 40% marks IN SEMESTER END EXAMINATION.
i.e 40 out of 100.

METHOD TO CARRY FORWARD THE MARKS

- ▶ A Student who **passes in INTERNAL ASSESSMENT but fails in the SEMESTER END EXAMINATION** of the course shall Reappear for the ATKT EXAMINATION of that course. However, his/her marks of the INTERNAL ASSESSMENT shall be carried over and he/she shall be entitled for GRADE obtained by him/her on passing of the complete course.
- ▶ A Student who **fails in the INTERNAL ASSESSMENT but passes in the SEMESTER END EXAMINATION** of the course shall Reappear for the INTERNAL ASSESSMENT ATKT of that course. However, his/her marks of the SEMESTER END EXAMINATION shall be carried over and he/she shall be entitled for GRADE obtained by him/her on passing of the complete course.

ATKT (ALLOWED TO KEEP TERM)

- A Student shall be allowed to keep term for Semester II irrespective of number of heads of failure in Semester I.
- A Student shall be allowed to keep term for Semester III if he/she passes each of Semester I and Semester II **OR**

If he/she fails in not more than two courses each of Semester I and Semester II.
- A Student shall be allowed to keep term for Semester IV irrespective of number of heads of failure in Semester III.
- A Student shall be allowed to keep term for Semester V If...

a) He/she passes Semester I, II, III and IV in full

OR

b) He/she passes Semester I and II in full and secured ATKT in the Second year by failing in not more than two courses in each of Semester III and Semester IV.

OR

c) He/she passes Semester III and IV in full and secured ATKT in the First year by failing in not more than two courses in each of Semester I and Semester II.

➤ A Student shall be allowed to keep term for Semester VI irrespective of number of heads of failure in Semester V.

➤ **REVALUATION**

1. A Student Can Independently Apply For Revaluation Or Photo Copy Or Both Simultaneously If He /She Desires So.

2. A Student Can Apply For The Revaluation With Whatever Marks He / She Secured **AND EVEN THE ZERO MARKS.**

3. A Student Can Apply For The Revaluation To As Many Subjects As He / She Desires.

4. The Marks Obtained After Revaluation Shall Be Accepted, If The Marks Awarded To A Paper As A Result Of Revaluation, Increase Or Decrease In Revaluation By 10% Or More Than The Maximum Marks Assigned To That Paper. And In Such Case(s) The Marks Originally Obtained By The Candidate In The Paper Shall Be Treated As Null And Void And The Marks Obtained By The Candidate After Revaluation Shall Be Accepted As The Marks Obtained In That Paper.
